(a) A person may question the eligibility of a candidate who has filed a declaration of candidacy with the director for a regional educational attendance area (REAA) [, COASTAL RESOURCE SERVICE AREA (CRSA),] or state-conducted local election, by filing a complaint with the director. A complaint regarding the eligibility of a candidate must be received by the director not later than the close of business on the fifth day after the filing deadline for the office for which the candidate seeks election.
