Statement:

What I stand for:

1. Illegal Immigration and Amnesty:

I am an immigrant. I support enforcing the current laws to secure the border. I oppose amnesty and spending tax funds for illegal aliens in the U.S.

Don Young voted for bill H.Amdt 789 in HR4745 that subsidized Section 8 Housing for illegals. Young also voted for bill HJ Res.59 to cut benefits to veteran retirees while allowing illegals to claim Child Tax Credits. Pro- amnesty U.S. Chamber of Commerce has endorsed Don Young.

2. Obamacare:

I will not vote for any bill that fully funds Obamacare. I will fight to defund and replace with alternative common-sense free market approach bill HR3121: American Health Care Reform Act.

Don Young voted for bill HR2775 (10/16/13) to fully fund Obamacare and increased the national debt. Obamacare made health care more expensive for 85% of Americans including mine. Congressional Budget Office expects 2.3 million job losses due to Obamacare.

3. National Debt:

I am very concerned about our futures \$17 trillion national debt, and the \$125 trillion retirement/entitlement debt. I will only vote for sustainable budgets, protecting Medicare and Social Security. I will not vote for slush funds benefiting big multi-national businesses over small family owned businesses.

Don Young voted for bills HR2775, HJRes59 and HR933 adding \$64 billion to \$17 trillion debt. Don Young picks winners and losers by voting for slush funds for big businesses while cutting benefits and assistance to poor working Americans.
