ORDER AND NOTICE TO RECALL REAA 18, SECTION 1
FOR REAA #18

Pursuant to the provisions of AS 14.08.081, AS 29.26.240 and 29.26.320, a recall election will be held for the voters in the REAA 18, Section I, Chatham School District on Tuesday, November 20, 2007 between the hours of 8:00 a.m. and 8:00 p.m.

The ballot will contain the grounds for recall and a rebuttal statement, if provided, followed by the following questions:

Shall Shelly Wilson be recalled from the Office of School Board member, Seat A, on the Chatham School District Board?

Shall Edward Gamble, Sr. be recalled from the Office of School Board member, Seat B, on the Chatham School District Board?

Shall Irene Paul be recalled from the Office of School Board member, Seat C, on the Chatham School District Board?

To vote in this election, a person must be registered in the boundaries of REAA 18, Section I by Sunday, October 21, 2007, which is 30 days before the election.

The question must be approved by a majority of the people who vote.

The election will be conducted by mail in accordance with AS 15.20.800 and 6 AAC 25.590 and in the general manner prescribed by Alaska's Election Code. There will be no polling place open for regular in-person voting on Election Day. An Absentee Voting Official (AVO) will be available in the Angoon City Clerk's Office, the Tenakee Springs City Clerk's Office and at the Denise Morris residence in Klukwan for 15 days prior to the election for Absentee In-Person voting. Absentee ballots can also be voted in person at any regional election office listed below beginning 15 days prior to the election.
