Subject: Recall Petition Application – Representative Lindsey Holmes, House District 19

The Division of Elections has reviewed the sponsor signatures submitted in the application for the above recall petition application.

The application must contain the signatures of voters equal in number to 10 percent of those who voted in the preceding general election. There were 8,080 votes cast in the 2012 general election in House District 19. Therefore, the application must contain signatures from at least 808 qualified voters.

We have determined 904 of the 1108 signatures submitted to be those of qualified voters. The application has a sufficient number of sponsors to qualify for circulation of a petition under AS 15.45.500. Attached is the petition statistics report.

I await your review of the grounds for recall to determine if the application will be certified or denied.
