CANDIDATE FILING REQUIREMENTS

Candidates running for Governor and Lt. Governor file jointly on the Declaration of Candidacy. The joint Declaration of Candidacy must be filed by **MONDAY, JUNE 1, 2026**. Below is a checklist provided as a convenience to a candidate filing for office. Candidates are free to declare candidacy in another format provided it complies with the provisions of AS 15.25.030.

CHECKLIST FOR FILING FOR OFFICE

- Complete your Declaration of Candidacy.** Both the candidate for Governor and Lt. Governor must complete the same joint Declaration of Candidacy. AS 15.25.030
- Sign your Declaration of Candidacy before a Notary.** Both the candidate for Governor and Lt. Governor must sign the same joint Declaration of Candidacy. A Notary is available at all Division of Elections offices. AS 15.25.030(a)
- Determine filing fee.** \$200 for the office of Governor and Lieutenant Governor team filing jointly (\$100 for each candidate). The fees are non-refundable. AS 15.25.050
- Complete a Financial Disclosure Statement with APOC on or before the JUNE 1, 2026 filing deadline.**
 - a) Non-incumbent candidates for Governor or Lieutenant Governor need to file a Public Official's Financial Disclosure Statement with the Alaska Public Offices Commission (contact APOC to ensure a current statement is on file). Since both candidates file jointly, both POFD statements must already be on file with APOC or filed simultaneously with the Declaration of Candidacy.
 - b) Incumbent candidates for Governor or Lieutenant Governor need to file a Legislative Financial Disclosure Statement with APOC (contact APOC to ensure a current statement is on file). Since both candidates file jointly, both LFD statements must already be on file with APOC or filed simultaneously with the Declaration of Candidacy.
 - c) A Public Official's Financial Disclosure Statement on file with a municipal clerk for a municipal office may not satisfy this requirement. A "current statement on file" with APOC is a financial disclosure statement that covers the reporting period of the prior year and was filed timely with APOC.
- File completed forms no later than 5:00 p.m. on the filing deadline, MONDAY, JUNE 1, 2026.** All Division of Elections Offices will be open 8:00 a.m. to 5:00 p.m. AS 15.25.040

- Thur., 06/11/26 Last day to file a complaint with the Division of Elections regarding the eligibility of a candidate. AS 15.25.042 and 6 AAC 25.260
- Tues., 06/16/26 Candidates who faxed filing materials to the Division of Elections by the June 1st deadline must have their mailed documents received by the Division of Elections by this date. AS 15.25.040(a)(2)
- Sat., 06/27/26 Last day for candidates to withdraw their names from Primary Election ballot. AS 15.25.055
- Wed., 07/22/26 **Candidate deadline for Official Election Pamphlet information material.** Candidates submit materials to the Division of Elections for the state's 2026 General Election voter pamphlet.

OFFICIAL ELECTION PAMPHLET INFORMATION

Filing to be in the Official Election Pamphlet is a separate process from the Declaration of Candidacy or Retention forms submission.

All candidates who wish to appear in the pamphlet must submit the materials listed below by the statutory deadline. The division recommends filing your materials as soon as possible. Materials should be submitted electronically. Forms for making the submission are available on the division's website at:

1. **Candidate Statement:** A biographical statement of 150 words or less and a position statement of 250 words or less. AS 15.58.030(e)
2. **Photograph:** A 5" x 7" photograph (five inches wide by seven inches high) or comparable resolution digital photograph taken within the last five years and limited to the head, neck and shoulders of the candidate. Digital files are preferred. All photographs will be printed in black and white. AS 15.58.030(f)
3. **Filing Fee:** Submit payment in the appropriate amount to the State of Alaska, Division of Elections. (Cash, check, credit card accepted.) AS 15.58.060(a)
 - a. \$300.00 – President of the United States, Vice President of the United States, United States Senator, United States Representative, Governor, Lieutenant Governor, Supreme Court Justice, Court of Appeals Judge
 - b. \$150.00 – Superior Court Judge, District Court Judge
 - c. \$100.00 – State Senator, State Representative

Prior to the General Election, the Division of Elections distributes the Official Election Pamphlet (OEP) to the households of registered voters. The pamphlet contains information about candidates and issues appearing on the General Election ballot. In addition, the information submitted by candidates for the OEP is posted to the division's website prior to the election in which the candidate will appear on the ballot.

*NOTE: For the Primary Elections, a ballot measure only pamphlet is mailed to voters only if a ballot measure appears on the Primary Election ballot. Candidate information **does not** appear in a Primary Election pamphlet.*

Statutory Deadlines:

- Presidential/Vice Presidential Candidates: **Wednesday, August 30, 2028** (AS 15.58.030(a))
- State/Federal Candidates: **Wednesday, July 22, 2026** (AS 15.58.030(b))
- Judicial Retention Candidates: **Friday, August 7, 2026** (AS 15.58.030(g))

LATE SUBMISSIONS WILL NOT BE ACCEPTED.

Translated Materials Deadlines:

- Presidential/Vice Presidential Candidates: **Monday, July 31, 2028** (6 AAC 25.720)
- State/Federal Candidates: **Monday, June 22, 2026** (6 AAC 25.720)
- Judicial Retention Candidates: **Wednesday, July 8, 2026** (6 AAC 25.720)

Materials for Alaska Native language translation must be received 30 days before the statutory deadlines. If submitted by this deadline, materials will be translated for a candidate for a federal or statewide office, a candidate for State Senate in Districts C, R, S, or T, a candidate for State Representative in House Districts 5, 36 – 40, or a judicial retention candidate for Supreme Court, Court of Appeals or judicial districts 2, 3 or 4. We **strongly encourage** you to submit your pamphlet material following this requirement so that the division can have your information translated to assist limited English proficient Alaska Native voters. We cannot accept already translated submissions.

NONPARTISAN TOP 4 PRIMARY IN ALASKA

Candidates must file their Declaration of Candidacy on or before 5:00 p.m. **Monday, June 1, 2026** for the **August 18, 2026** Primary Election required by AS 15.25.030. When filing for office, candidates must have their Financial Disclosure Statement already on file with the Alaska Public Offices Commission or must submit it simultaneously with their Declaration of Candidacy.

Any registered voter who meets the requirements of AS 15.25.030(a) and seeks to become a candidate in the Primary Election can file a declaration of candidacy. A Nonpartisan Top 4 Primary is used to determine which candidates will advance to the General Election. All candidates will appear on one ballot and there is no limit to how many candidates can file for each race in the Primary Election.

In accordance with Alaska's laws, a Primary Election candidate does not have to be a member of a political party or group to run for office. If a candidate is registered as affiliated with a political party or group, it does not imply the candidate is nominated by, approved by, or associated with that particular party or group.

METHODS FOR FILING YOUR CANDIDATE PAPERWORK

Candidates may file a Declaration of Candidacy for the August 18, 2026 Primary Election to any Division of Elections office. The declaration and filing fee must be filed simultaneously on or before 5:00 p.m. Monday, June 1, 2026, using one of the methods listed below:

- **In person:** A Declaration of Candidacy may be delivered in person to any Division of Elections regional office no later than 5:00 p.m. on June 1st or the Director's Office, located at 240 Main Street, Suite 400, Juneau, AK.

- **By mail:** A Declaration of Candidacy sent by mail must be received by the Division of Elections on or before 5:00 p.m. on June 1st. If the postmark is illegible, a dated receipt from the post office where dispatched shall be acceptable evidence of mailing. Declarations may be mailed to any Division of Elections regional office or to the Director's Office at P.O. Box 110017, Juneau, AK 99811-0017.

- **By reliable electronic transmission:** A Declaration of Candidacy or a copy of the statements made in paragraphs (1) – (5) of the declaration as required by AS 15.25.030(a) may be electronically transmitted by email to elections@alaska.gov or by fax at (907) 465-3203 or to any Division of Elections regional office and must be received by the division no later than 5:00 p.m. on June 1st. The original declaration containing paragraphs (1)-(16), as required by AS 15.25.040(a), must be received by the Division of Elections within 15 days of the filing deadline.
