

**Notice of Election of the Incorporation of the Proposed Second Class
City of Edna Bay
Tuesday, September 16, 2014**

This Election Will Be Conducted By Mail

There will be no regular polling place open on Election Day.

◆ **The election is to vote on the following question and offices:**

Ballot Question:

Shall Edna Bay be incorporated as a second class city?

Initial Elected Offices:

If a majority of voters approves the ballot question, the City of Edna Bay will be governed by a seven-member city council elected at large.

- ❖ City Council (seven seats)

◆ **Are you interested in becoming a candidate?**

Candidates for the office of city council members must be qualified voters and must reside within the boundaries of the proposed City of Edna Bay. Interested candidates must file a completed Nominating Petition Packet (including a Public Official's Financial Disclosure Statement) in order to appear on the ballot.

Nominating Petition Packets will be available beginning Tuesday, July 1, 2014 at the following locations:

Candidate Filing Deadline is 5:00pm on July 22, 2014

◆ **Your ballot will be mailed to you on or before Friday, August 22, 2014**

You have from the time you receive your ballot until Election Day to vote your ballot. If you do not receive your ballot, if your mailing address has changed, or if you will not be at your current mailing address for this election, contact the Absentee and Petition Office at (907) 375-6400.

◆ **Election Day is Tuesday, September 16, 2014**

For your ballot to be counted, you must:

1. Sign the return ballot envelope.
2. Provide at least one identifier on the return ballot envelope.
3. Have your signature witnessed. Ask one person over the age of 18, the postmaster or the election official (Charleen Bartels) to be your witness. You must have proper ID available.
4. Ballots must be postmarked on or before Election Day, Tuesday, September 16, 2014. You may also place your voted ballot in the ballot drop-box located at Charleen Bartels' house.

If you require assistance, would like to vote absentee in-person, or need a new ballot, please contact the local absentee voting official (Charleen Bartels). She is available at the address listed above on weekdays starting September 2, 2014 through Election Day, Tuesday, September 16, 2014 from 2:00pm – 4:00pm or "As Needed" by calling (907) 594-6304. In addition, absentee voting and other assistance will be available at the Juneau, Anchorage, Mat-Su, Fairbanks and Nome election offices.
