Position Statement

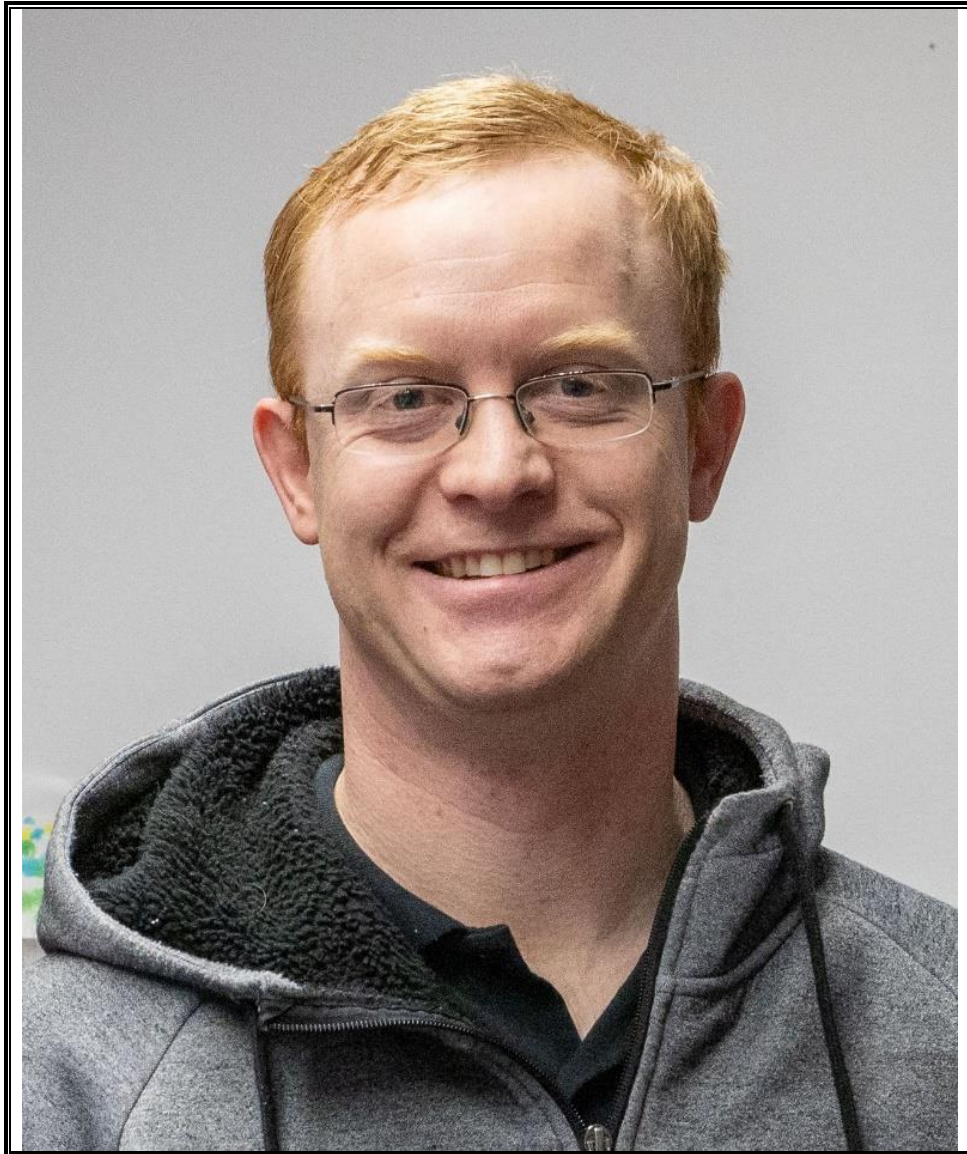
