I believe that the size, scope and footprint of state government must be restrained and reduced to promote a sustainable budget.

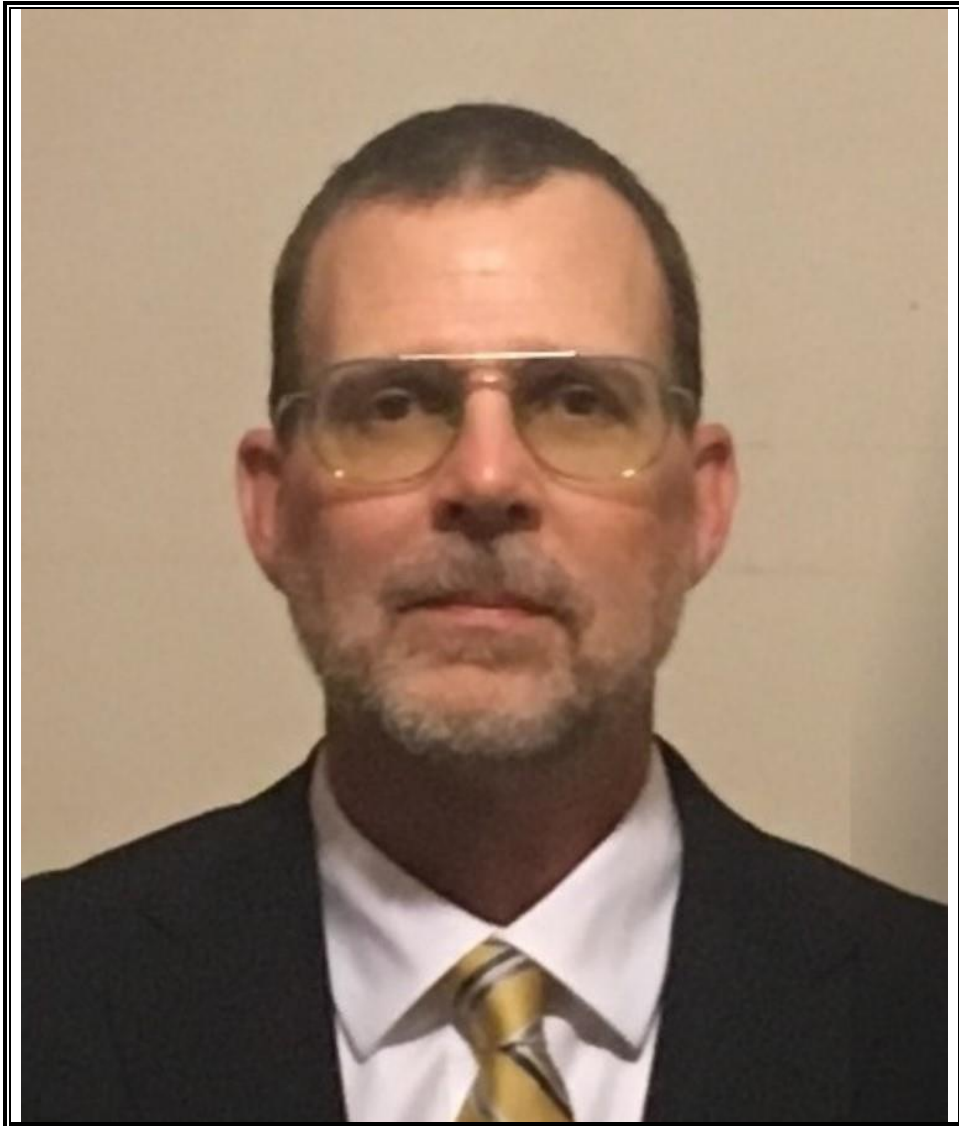
I am a defender of the PFD and do not support the cuts in the dividend that violate current statute on the books.
