The Division of Elections has reviewed the sponsor signatures submitted in the application for the above referenced initiative petition.

We have determined 142 of the 149 signatures submitted to be those of qualified voters. The application has a sufficient number of sponsors to qualify for circulation of a petition under AS 15.45.030.
