**ORDER AND NOTICE OF ELECTION**  
**OF THE PROPOSED INCORPORATION OF THE DELTANA BOROUGH**

Notice is hereby given that pursuant to the provisions of AS 29.05.110 - 29.05.120, an election will be held in the proposed Deltana Borough area on Tuesday, August 21, 2007 to determine:

1. Shall the Deltana Borough be incorporated as a unified municipality? (Under AS 29.05.140(d), incorporation of the Deltana Borough will result in the concurrent dissolution of the existing City of Delta Junction.)
2. Do voters of the proposed Deltana Borough hereby ratify the "Agreement for Payment in Lieu of Taxes" between the City of Delta Junction and Teck-Pogo, Inc., included as Exhibit K of the Petition; and shall the Deltana Borough be authorized to levy a 3 percent home heating fuel and vehicle gas sales tax and a 10 percent tax on the sale of electrical power? Approval of this proposition is a condition for incorporation; i.e., voters must approve this proposition for incorporation to occur.
3. If a majority of votes are cast in favor of the incorporation of the Deltana Borough, the Deltana Borough will be served by a mayor and seven borough assembly members, all elected at large.

The election will be held Tuesday, August 21, 2007, and will be under the administration and supervision of the Director of Elections. The proposed borough is to be named the Deltana Borough. The boundaries ordered for the proposed borough are those in the petition approved by the Local Boundary Commission in its Statement of Decision dated April 12, 2007.

Candidates for the office of Mayor and Borough Assembly Member must be a qualified voter who is registered and who has been a resident of the proposed Deltana Borough area for at least 1 year preceding the election. The mayor and each assembly member shall be elected at large.

Individuals seeking office on the initial mayor or borough assembly and desiring to have their name appear on the ballot must file nominating petitions that include the name and address of the nominee and a statement of the nominee that the nominee is qualified under the provisions of Alaska Statute Title 29 for the office of mayor or assembly. Petitions to nominate the mayor and assembly must include the signature and resident address of 50 voters in the area of the proposed borough. AS 29.05.120(c). Signed petitions must be received by the Director of Elections, P.O. Box 110017, Juneau, AK 99811-0017 by 5:00 p.m. on Wednesday, June 27, 2007.

Any person who is a qualified voter and has resided within the boundaries of the proposed Deltana Borough since April 24, 2007 (30 days before the date of this election order) may vote in this election. AS 29.05.110(b).

The election will be conducted in the general manner as prescribed by the Alaska Election Code and will be conducted by mail in accordance with AS 15.20.800, 6 AAC 25.590 and 6 AAC 27.160 through 27.165. There will be no polling place open for regular in-person voting on election day. An Absentee Voting Official (AVO) will be available in Delta Junction 15 days before the election. Absentee ballots may also be voted in person at any of the election offices listed below. A notice of the election will be mailed to each registered voter in addition to candidate filing information.


